### 11.1. Information on toxicological effects

#### Ingestion

Ingestion may be fatal or may produce serious damage to the health of the individual.

Swallowing of the liquid may cause aspiration of vomit into the lungs with the risk of haemorrhaging pulmonary oedema progressing to chemical pneumonitis. Serious consequences may result.

#### Eyes

Irritation may also be present after prolonged or repeated exposure, this may result in contact dermatitis (non-allergic). Dermatitis is often characterised by skin redness (erythema) and swelling (oedema) which may progress to blistering (visiculation) scaling and thickening of the epidermis.

Entry into the blood-stream through cuts, abrasions, puncture wounds or lesions may produce systemic injury with harmful effects. Ensure that skin is suitably protected

Material on the skin evaporates rapidly and may cause tingling, chilling and even temporary numbness.

#### Inhalation

Ensure adequate ventilation to keep exposure at minimum.
