1. SAFETY

1.1. GENERAL

- ✓ Ensure the lamp is fully charged before initial use.
- **X DO NOT** turn the lamp on when it is being charged.
- **X DO NOT** shine directly into your, another person's or an animal's eyes.
- **X DO NOT** allow children to use the lamp.
- **X DO NOT** handle or move the lamp whilst it is being charged.
- **X DO NOT** use the lamp if you suspect that the battery or the lamp casing is damaged.
- X DO NOT leave battery in a discharged state, recharge battery immediately. Before storage, fully recharge the battery, subsequently recharge the battery at least once every six months of non-use.
- 1.2. ELECTRICAL SAFETY FOR USE OF CHARGER. USE ONLY THE SUPPLIED CHARGER PLUG FOR CONNECTING LAMP TO THE POWER SUPPLY.
 - WARNING! It is the user's responsibility to read, understand and comply with the following electrical instructions: You must ensure the risk of electric shock is minimised by the installation of appropriate safety devices. An RCCB (Residual Current Circuit Breaker) should be incorporated in the main distribution board. We also recommend that an RCD (Residual Current Device) is used with all electrical products, particularly portable equipment which is plugged into an electrical supply not protected by an RCCB.
 - You must also read and understand the following instructions concerning electrical safety.
- 1.2.1. The Electricity At Work Act 1989 requires all portable electrical appliances, if used on business premises, to be tested by a qualified electrician, using a Portable Appliance Tester (PAT), at least once a year.
- 1.2.2. The Health & Safety at Work Act 1974 makes owners of electrical appliances responsible for the safe condition of the appliance and the safety of the appliance operator. If in any doubt about electrical safety, contact a qualified electrician.
- 1.2.3. You must ensure that you:

Inspect the charger plug, cable and connector for wear and damage to ensure items are safe before connecting to the mains power supply.

- 1.2.1. If worn or damaged **DO NOT** use.
- ▲ **IMPORTANT**: Check that the voltage marked on the charger plug is the same as the lamp.
- 1.2.2. Uncoil the cable between charger and the lamp.
- **X DO NOT** pull the charger plug from the mains socket by the lead.
- WARNING! DO NOT use any other type of charger with this product, other than the supplied mains or car charger. Failure to observe this warning could result in injury and or fire and will invalidate the warranty.
- **X DO NOT** try to take the charger plug apart.
- **X DO NOT** use the charger plug to charge or power any other electrical item.
- **X DO NOT** get the charger wet, or use in wet, damp conditions (for indoor use only).

1.3. BATTERY SAFETY

- WARNING! To reduce the risk of burns or fire:
- **X DO NOT** attempt to open, disassemble, modify or service the battery pack.
- **X DO NOT** crush, puncture, short external contacts or dispose of in fire or water.
- **X DO NOT** expose to temperatures above 60°C (140°).
 - Replace only with the battery pack designated for this product.

Recycle or dispose of used battery as stipulated by local regulation.

2. INTRODUCTION

Mini, lightweight lamp with exclusive patented design owned and registered to Sealey. Unique and innovative 360° swivel and tilt function enables the light source to be positioned in any direction. Featuring a super bright 2W COB LED light source, which gives an even and constant spread of light. Produces up to 180 lumens with a CRI-80 rating. Recessed lens for added protection. 1W High power LED located in top of the lamp for directional torch use, produces up to 90 lumens. Rubber covered magnet in base and swivel hook for hands-free operation. Hook doubles as pocket/belt clip for easy carrying when not in use. High quality rechargeable 3.7V 1.5Ah li-polymer battery for longer life, no memory effect and a much slower discharge than traditional Ni-MH batteries. Micro USB charging port. Supplied with mains charger and USB cable.

the battery fitted to this cordless tool is considered to be a consumable item and its ability to accept a charge will reduce over time. We will warranty it against mechanical and electrical defect for a period of one year - this does not cover fair wear and tear. If the battery is not properly charged before first use, or regularly conditioned, its capacity will diminish. Under these circumstances we will not replace the battery even if it is less than one year old.

Note: fully charge the battery before first use.

Note: the Lithium battery does not suffer from memory effect and once fully charged may be stored for up to six months without another charge.

4. OPERATION

Refer to fig.1

4.1. Connect the charger into the charge socket on back of the lamp. Plug into power supply and turn on, the charging LED on the lamp will light RED to show charging has commenced.

- **4.2.** When the battery has fully charged the LED will turn GREEN.
- **4.3.** Direct the lens away from your eyes before switching on.
- 4.4. Toggle the lamp between 1W end and 2W COB using the push switch.
- **4.5.** Suspend the lamp by the hanging hook. When the light is hanging from the hook it can be rotated through 360° for more precise positioning.
- **4.6.** Alternatively use the magnet on the base to attach the lamp to any ferrous surface.





Battery Removal

Remove the 4 screws on the back of the lamp. Remove the back casing and disconnect the wiring from the circuit board. Remove the battery cover and pull the battery off the casing. Dispose of according to local government guidelines.


