1. SAFETY

1.1. GENERAL

- ✓ Ensure the torch is fully charged before initial use.
- **DO NOT** turn the torch on when it is being charged.
- * DO NOT shine directly into your, other person's or an animal's eyes.
- **x DO NOT** allow children to use the torch.
- **× DO NOT** handle or move the torch whilst it is being charged.
- * DO NOT use the torch if you suspect that the battery, the torch casing or the cable is damaged. Consult your Sealey Stockist.
- * DO NOT leave battery in a discharged state, recharge battery immediately. Before storage, fully recharge the battery, subsequently recharge the battery at least once every six months of non-use.

1.2. BATTERY SAFETY

- **WARNING!** To reduce the risk of burns or fire:
- **DO NOT** attempt to open, dismantle, modify or service the battery pack.
- * DO NOT crush, puncture, short external contacts or dispose of in fire or water.
- **× DO NOT** expose to temperatures above 40°C or below 10°C.
- **DO NOT** expose to direct sunlight for long periods of time.
- **× DO NOT** expose to moisture.
- **WARNING! DO NOT** place the torch face down while in use.
- \checkmark Replace only with the battery pack designated for this product.

2. INTRODUCTION

Side-mounted push-button to switch between two brightness settings of 100 or 300 lumens. Press and hold button for 500 lumens super beam. Features a magnet on the end, along with a metal belt clip on the back for hands-free operation. USB-C charging port. Supplied with charging lead.

4. OPERATION

4.1. PRESS ON/OFF TO OPERATE (FIG.1)

- 4.1.1. First press: High beam (300 lumens)
- 4.1.2. Second press: low beam (100 lumens)
- 4.1.3. Third press: switches everything off.
- 4.1.4. Long press: 500 lumen super beam.

4.2. CHARGING

- 4.2.1. Open the cover on the side of the mini light.
- 4.2.2. Plug the USB-A into a 5V USB outlet.
- 4.2.3. Insert Type-C connector into the charging port on the side, for a full charge expect it to take around 2.5hrs.

5. MAINTENANCE

- 5.1. Keep lamp clean and check for damage before every use. If damage is observed, remove from use until unit is repaired.
- 5.2. The battery is not designed to be removed.
- 5.3. The battery fitted to this light is considered to be a consumable item and its ability to accept charge will reduce over time. We will warranty it against mechanical and electrical defect for a period of one year, this does not cover fair wear and tear. If the battery is not properly charged before first use, or regularly conditioned, its capacity will diminish. Under these circumstances we will not replace the battery even if it is less than one year old.





ENVIRONMENT PROTECTION
