#### ELECTRICAL SAFETY FOR USE OF CHARGER.

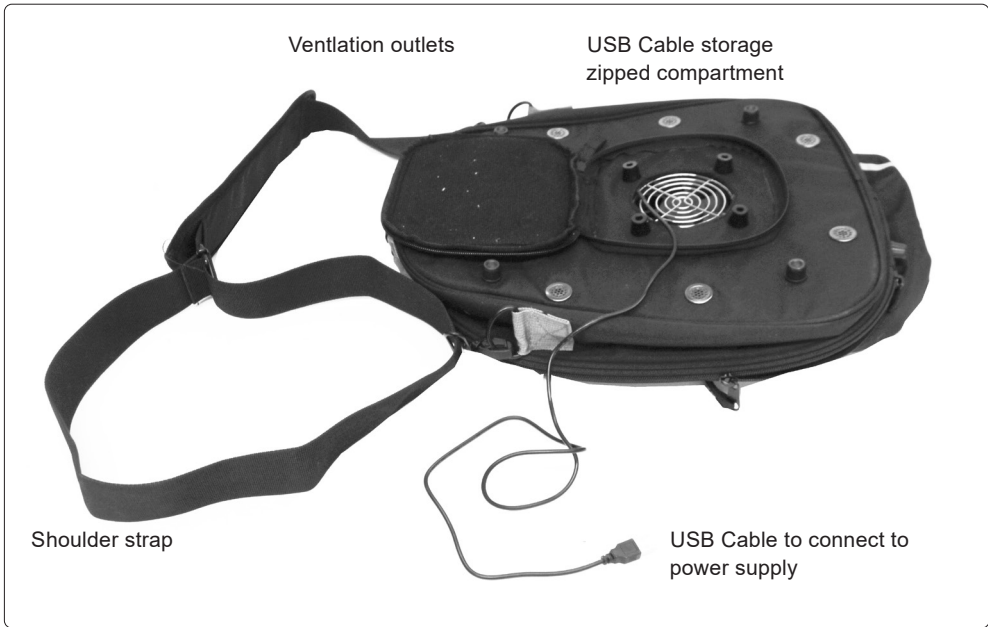
- ✓ Use only the supplied USB cable for connecting the helmet cooling bag to its power supply.

- ✓ Ensure that you inspect the USB cable and connections for wear and damage to ensure items are safe before connecting them. If worn or damaged **DO NOT** use.
- ❑ **WARNING!** There are no user serviceable components. **DO NOT** dismantle.
- ❑ **WARNING!** For indoor use only.
- ✗ **DO NOT** pull USB socket by the lead.
- ✗ **DO NOT** overfill this helmet cooling bag; it should only be used for the designed purpose.

An integral, quiet running fan will quickly and conveniently dry and cool your helmet whilst in the bag. Inhibiting the build-up of damp and odour. Helps prevent the build-up of bacteria, so your helmet smells fresher. Improves the life span of the linings and impact materials in your helmet. The unit comes with a USB adapter for connection to your vehicle or to a power pack. Making it ideal for rides out, race/track days, as well as using at home after your ride out/commute. Made from a strong canvas, and the inner is fully lined to best protect your equipment.
