1. SAFETY

- ✗ **DO NOT** charge in damp conditions.
- ✗ **DO NOT** turn the torch on when it is being charged.
- ✗ **DO NOT** shine directly into your, another person's or an animal's eyes.
- ✗ **DO NOT** allow children to use the torch.
- ✗ **DO NOT** handle or move the torch whilst it is being charged.
- ✗ **DO NOT** use the torch if you suspect that the battery or the torch casing is damaged.

2. INTRODUCTION

Fully versatile neck torch lets you light up your workspace and keep your hands-free. Dual use, each torch has a magnet and individual battery where you can turn your neck torch into two inspection lamps. Can be mounted to any ferrous surface. Each light produces up to 150lm each at a combined total output of 300lm. While mounted each torch can be rotated up to 105°. Features two light modes, full beam and half beam for a longer runtime.

4. OPERATION

- 4.1. Pressing the power button once will turn the light on full power, pressing it again will dim the light and pressing a third time will turn the light off.
- 4.2. **CHARGING**
- Note:** Each torch needs to be charged individually. The torches can also be detached from the collar which may make charging more convenient.
- 4.2.1. Remove USB socket cover on the torch.
- 4.2.2. Connect the USB lead to the port on the rear of the battery pack and a USB power socket. Turn on the power supply.
- 4.2.3. Switch off power supply, remove charging lead and replace socket cover on battery pack.
