INSTALLATION AND OPERATING INSTRUCTIONS

Keep this manual safe for reference and future maintenance

1. Introduction

The Dummy Wireless Bell Box Alarm:

- is designed to be fitted to the front of the property in a highly visible position, providing a permanent visual deterrent to intruders.
- has flashing lights to indicate when it's active. It is impossible to differentiate it from the real one.
- has a typical battery life of 1.5 years or more before they need changing.

2. Installation

- Remove the bell box cover by unscrewing the single screw located on the lid.
- Insert 2 x fresh alkaline 'AA' cells, noting their polarity.
- The dummy bell box alarm is now active and the lights will flash.
- The bell box is now ready for mounting. Please choose the best location (highly visible position) for mounting. Do not replace the cover yet.
- Using the large screws and wall plugs provided, mount on the desired wall through the mounting holes.
- Fix the bell box cover with the securing screw.

3. Maintenance

The product may be cleaned with a soft damp cloth and then wiped dry. Do not use abrasive, solvent based or aerosol cleaners as this may damage and/or discolour the product. Do not allow water to enter or attempt to clean inside the unit.

4. Batteries

Do not allow the batteries to corrode or leak as this may cause permanent damage to the product. Take care to insert the batteries with the correct polarity as shown inside the battery compartment. Do not mix new and old batteries or different types of batteries. Do not use rechargeable batteries. At the end of their useful life the batteries should be disposed of via a suitable recycling centre. Do not dispose of with your normal household waste. DO NOT BURN.

5. Alarm System Limitations
